Epigenetic Principle - need to pass through successive clearly defined stages. Each must be passed through.

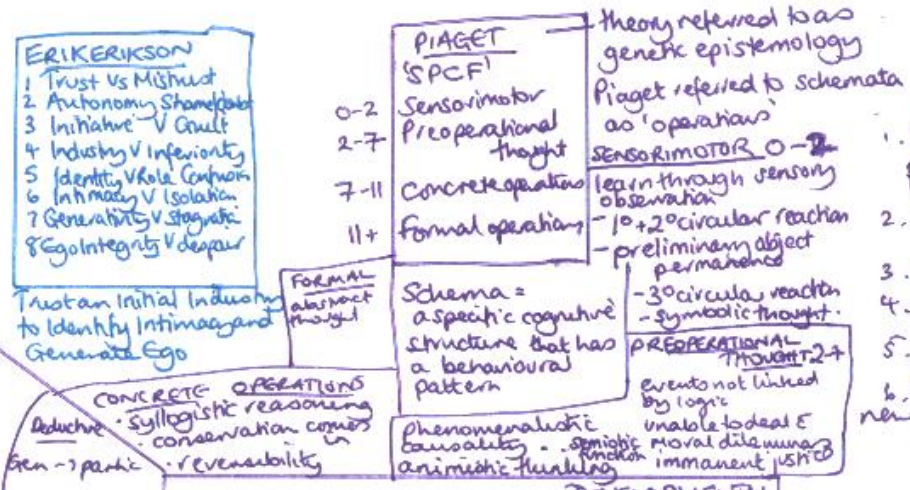
Theodore W. Lidz - exponent of life-cycle theory

Winnicott - transitional object not used by institutionalized child



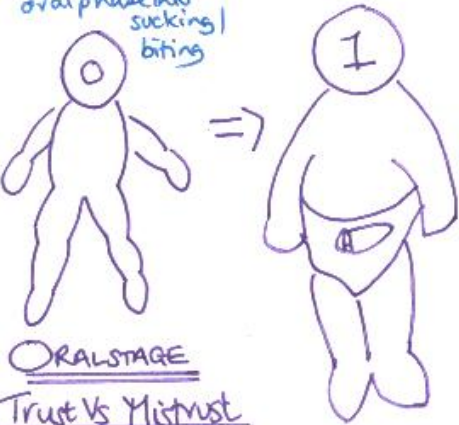
ADOLESCENCE Identity Vs Role Confusion

- Leads to
1. Separation from parents + independence
 2. Establish sexual identity
 3. Commitment to work
 4. Development of moral system
 5. Capacity for loving relationships
 6. Form new relationships w/ parents

Industry vs Inferiority

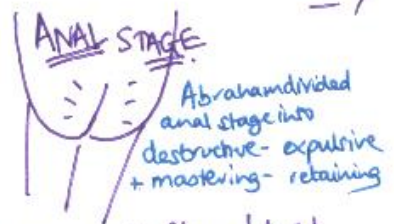
Abraham divided oral phase into sucking / biting



ORAL STAGE

Trust Vs Mistrust
Sensorimotor
- If unsatisfactory may have difficulty forming intimate relationships.
8/12 stranger anxiety
- separation anxiety - evidence that bonding has occurred.

1 → 2/3



Autonomy Vs Shame / Doubt

Develop a sense of being in control of self.
Pleasure is gained at achieving bladder control etc.
Exploratory behaviour begins - indicating the strength of attachments.
Some exploratory behaviour has to be restricted: (fire, running into road)
→ temper tantrums (child doesn't get own way)

GENITAL STAGE

Initiative Vs Guilt

Socialization:
Sexual identity established
Conscience develops
Defence mechanisms begin
Magical thinking reflects child's confidence in being allowed to express themselves
Psychoanalytically → oedipal conflict
- feel rivalry with parent of same sex for attention of other parent.
→ eventually overcome by identification with same sex parent.

- Sensorimotor: 10-20° circular reaction, object permanence, symbolic thought
- Preoperational: thought, phenomenalistic causality, animistic function, animistic thinking, immanent thought
- Concrete operations: reversibility, conservation, syllogistic reasoning
- Formal operations: abstract thought, hypothetico-deductive reasoning

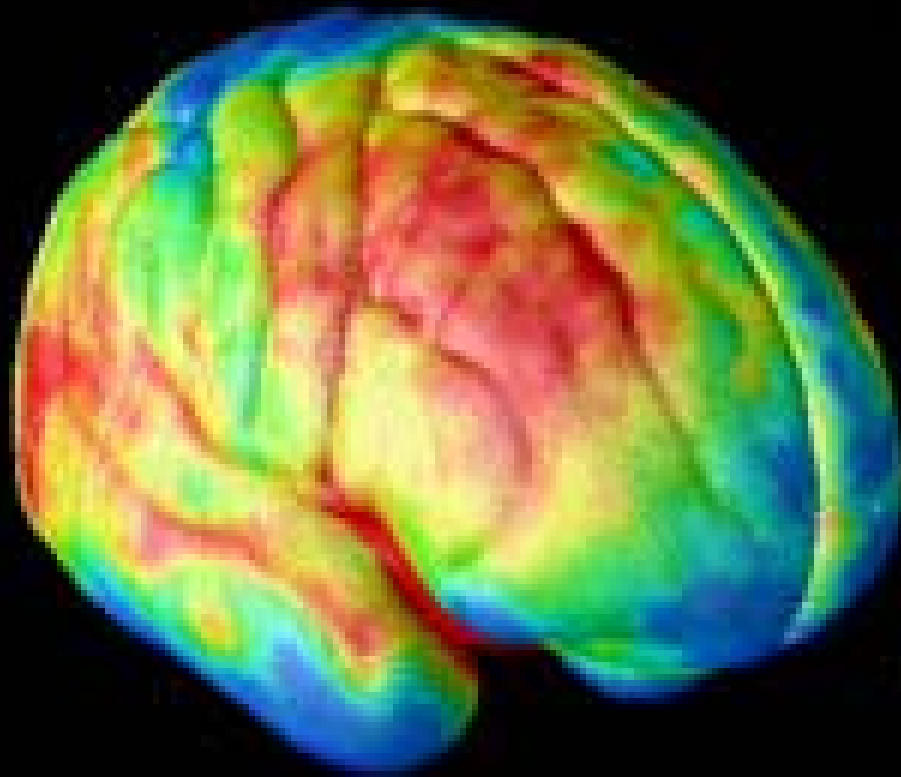
Defence - base one =
