#### Building a stronger Australian judiciary

Welcome to the NJCA 2024 Winter newsletter. Since our last newsletter, the NJCA has delivered ten programs in Brisbane, Canberra, Melbourne, Sydney and Perth. It has certainly been a busy few months.

In April, we delivered the *AI* and the *Court Symposium* at the National Gallery of Australia. This important judicial learning event was well-received, predominantly due to dynamic presentations by Australian and international experts in their respective fields. Thank you to all who attended and participated.

We also held the *John Doyle Oration* at the National Portrait Gallery, where the inaugural address was delivered by Chief Justice Stephen Gageler AC. It was a privilege for the NJCA to share this special evening with our guest of honour, his family and distinguished attendees while honouring the pioneering work and judicial education leadership of the first NJCA Council Chair, the Honourable John Doyle AC KC. The oration and moments captured during the evening are showcased in our "Spotlight On" feature.

Judgment writing was the focus of much of April and May. The NJCA welcomed Professor Virginia McRae from the Faculty of Law at the University of Ottawa in April for a two day "train the trainer" intensive to inform our *Mastering Judgment Writing (Writing Better Judgments III)* program for 2025. In May, I travelled to Toronto at the invitation of the National Judicial Institute of Canada (*NJI*) and the Canadian Institute for the Administration of Justice (*CIAJ*), to observe the Canadian approach to *Mastering Judgment Writing*. This was a invaluable opportunity to engage in best practice judicial education discussions with the judicial and executive leaders of the NJI and CIAJ. It also provided a comparative validation of the NJCA's pathway for excellence in judgment writing, namely *Writing Better Judgments I, II and III*.

In early June, the Chief Justices of the State and Territory Supreme Courts elected Chief Justice Lucy McCallum as their nominee member on the NJCA Council. This was followed by the subsequent announcement by the Chief Justice of the High Court of Australia, the Honourable Stephen Gageler AC, of Chief Justice McCallum as the new NJCA Council Chair. I extend my heartfelt gratitude to departing NJCA Council Chair, Chief Justice Christopher Kourakis, Supreme Court of South Australia, for his leadership and lasting contribution to judicial education in Australia. ### In conversation with NJCA Council Chair, Chief Justice Lucy McCallum



You have been a champion of judicial education for a long time. Why do you see judicial education as an essential part of the institutional architecture?

There is an increasing acceptance that to be a good judge, it is not enough to be a good lawyer or even a fine jurist. The transition from legal practice to judicial office is huge. As with any kind of expertise, much of the learning that is essential can only be gained on the job. But, of its nature, the job is ordinarily undertaken alone, unsupervised except on appeal. If judicial officers are to be properly supported in the development of their craft, judicial education led by experienced, senior judicial officers must be widely available and properly funded.

If there was ever any considered resistance to this idea, it has long since been shown to be misconceived. To develop judicial education is not to succumb to populism. Its single purpose is to support judicial officers to acquire the skills and learning required to uphold the rule of law. The importance of this undertaking was recognised by Chief Justice Stephen Gageler at the NJCA's 20th anniversary when he said: "The beginning of judicial wisdom is having the humility to recognise that there will always be things one simply does not know and skills one has not yet mastered. Recognising those human weaknesses is the beginning of judicial education."



#### What do you see as the role of the NJCA?

The NJCA plays an important national role in being able to cater in a flexible way for the educational needs of judges, magistrates and tribunal members across Australia, which are necessarily as diverse as their jurisdiction. I am looking forward to working with others who share my interest in judicial education and to continuing our collaborations with the Judicial Commission of NSW and the Judicial College of Victoria along with the Australian Judicial Officers Association and the Australian Institute of Judicial Administration. I would like to see a formal coalition of state-based and national education bodies with a view to capturing synergies, avoiding duplication, making the best use of limited funding and casting a wide net for judicial education in Australia.

The NJCA will also continue to develop international relationships with judicial colleges in Canada, New Zealand and Singapore. Judicial education serves many purposes – foundational, preventative, remedial, and aspirational. It can have a transformative impact, which is important as we embrace a more diverse judiciary in an Australian society with rightfully high expectations. The NJCA's reputation as a world-class educator is well-earned, thanks to strong governance and a dedicated team.

#### Where did you start your judicial education journey?

Since the terrifying moment of my own swearing-in as a puisne judge of the Supreme Court of New South Wales on 31 January 2008, I have hungered for the learning that might guide me to justice and spare me from ignominy.

# "Spotlight On" John Doyle Oration





On 6 April 2024, the Chief Justice of the High Court of Australia, the Honourable Stephen Gageler AC SC, delivered the inaugural *John Doyle Oration*. The oration celebrated the vision, leadership and lasting impact on the judicial education and training landscape in Australia made by the Honourable John Doyle AC KC, the first Chair of the NJCA Council.

The oration was an opportunity for judicial officers from across Australia to reflect on the growing importance of judicial education and the integral role of the NJCA as the national educator. The Chief Justice of the High Court, the Hon Stephen Gageler AC, reflected on this and John's impact stating, "Without question, John made judicial education part of the institutional architecture of the Australian judiciary. And, without question, the Australian judiciary and the Australian public are better off for it."

Chief Justice Christopher Kourakis outlined during the evening how the NJCA continues to build upon John Doyle's legacy. We honour his work and the significant efforts of those judicial education pioneers by delivering outstanding programs to judicial officers around the country and by never ceasing to be innovative and open to new ideas. Attendees included a significant number of NJCA life members and this was a visible reminder that our governance bodies, the NJCA Council and the NJCA Program Advisory Committee, along with our program committee members, stand on the shoulders of giants and that through collective learning we harness the ability to share, preserve, and build upon knowledge and skills over time.

His Honour spoke to a variety of things which impact judges from judgment writing to vexatious litigants through secondary trauma. We thank his Honour for sharing his invaluable insights and wisdom.





Professor McRae is internationally renown for her expertise and experience in delivering legal writing training for judges and we were honoured to welcome her to Australia.

Already delivered this year in Canberra and Adelaide, Part One of the *Managing Sexual Assault Hearings* program was delivered in Melbourne in April and in Brisbane in May to full conference rooms of engaged participants.

# Family Violence in the Court May, Perth

The NJCA Family Violence in the Court program was delivered in Perth in May. The judicial learning outcomes of the program have evolved so as to expressly link social context training with immediately practical and useable court-craft skills. As well as defining the socio-cultural facets of coercive control, the potential signs and indicative risk factors, such as prior strangulation, in a court setting, participants workshop best practice judge-craft skills.

Our guest speakers, educator Jess Hill and academic, Professor Heather Douglas both delivered powerful contemporary sessions. These are complimented by skills based sessions such as *Using Judicial Narrative and Voice*, aimed at helping maintain the focus for judicial officers on perpetrator accountability to others, as well demonstrating how to recognise and avoid invitations to collude.

Importantly, the program leads judicial officers through the efficient use of the *National Domestic and Family Violence Bench Book* to maximise judicial productivity. The program also explores intra-personal and extra-personal tools to identify and combat vicarious and cumulative trauma providing specific strategies to adopt so as to maintain judicial well-being and longevity on the bench.

The Family Violence in the Court program will be delivered a further three times this year.

#### Oral Decisions May, Sydney

In May, the NJCA delivered our *Oral Decisions* program to 28 judicial officers from across Australia. Critical to the program design and differentiate learning outcomes, this intensive two day program is delivered by over 16 judicial presenters, facilitators and voice coaches.

Participants are guided through the 5C's of oral decision making, templates, note taking, voice coaching, as well as targeted experiential judicial learning workshops. The NJCA is committed to maintaining the judicial learning outcomes of the program - enhancing judge-craft skills - as evidenced by the ratio of experienced judicial officer facilitator to judicial officer participants. The captivating nightscapes of Vivid Sydney were an added bonus!

Oral Decisions will be delivered twice next year, in Sydney in April and again in Perth in October.

## Writing Better Judgments I June, Perth

In late June the NJCA's flagship program, *Writing Better Judgments I* program was delivered to a large and highly engaged group of judicial officers in Perth. A special thank you to Chief Justice Peter Quinlan who was able to join us to give the opening keynote address.

This program, designed for experiential judicial learning, sees participants submit a written judgment for critiquing by experience judicial facilitators, writers and peers in structured workshops. Judgments are rewritten, reviewed, and refined over the three days, importantly allowing time for individual judicial reflection and peer discussion.

Participants leave this program able to prepare and plan for an issues-based written judgment, underpinned by the 5Cs. They are able to identify, frame and resolve the factual and legal issues and structure an of issues-based judgment and then confidently take the next step in judgment structure. They learn how to prepare a powerful introduction which signposts the whole judgment and learn the importance of language use, sentence and paragraph structure.

The NJCA and the WBJ I program committee look forward to returning to Perth next year.

National Magistrates and Local Courts Orientation Program



The program gives practical and readily usable knowledge and skills to participants so as to improve judicial officer confidence and writing ability and in turn, productivity.

This program provides a theoretical foundation which leads into the larger, practical component giving participants the opportunity to practice delivering oral decisions. This is a highly interactive whereby experienced judicial officers and facilitators give individualised feedback designed to directly enhance participant skills.

At the heart of the program is the opportunity to engage in experiential learning sessions with experienced facilitators, voice coaches and communication experts.

### Children and the Court 5-6 June 2025, Sydney



Using professionals with a range of expertise and experienced judicial officers, this programs aids in understanding issues across child and juvenile justice. The program is applicable to judicial officers working across all areas from family law, criminal matters and even child care and protection matters. The program combines judicial knowledge with enhanced court craft skills, and strategies to apply child friendly procedures through a rights of the child lens.

#### Judicial Officers with Leadership Responsibilities 10 - 12 September 2025, Sydney



This thought-provoking program is focused on practical outcomes and designed especially for court leaders facing complex environments, contemporary changes and pressures of external scrutiny.

The focus of this program is on the qualities that a judge, magistrate or tribunal member with leadership responsibilities needs to develop and on their practical application.

### **New NJCA Programs - Coming 2025**

### Writing Better Judgments III 30 April - 2 May 2025, Sydney

As judges gain more experience they usually find they have to deal with cases of greater complexity and difficulty - cases in which there is a multitude of issues.

The program rationale has been created by judicial officers who will lead you though experiential learning sessions that address skills and techniques required by senior judicial officers who preside over long trials and who prepare, manage, decide and produce large and complex judgments and /or have specific audience needs.

### Advanced Judicial Skills and Techniques 29-30 May 2025, Sydney

This program has been designed by the NJCA as a response to ongoing participant feedback seeking a court-craft, skills based program for judges who have been on the bench for 3-5 years.

The program will explore discretion and fact finding, managing high conflict courtrooms, best practice court-craft strategies of the fast but fair trial as well as expert evidence and forensic issues.

#### Indigenous Justice Program 8-9 September 2025, Sydney

Delivering justice for Indigenous Australians requires an understanding of and training in cultural humility and cultural competency. This program is designed to enable participants to learn and reflect as judicial officers on how the past effects the present, how lived experiences impact upon intergenerational trauma and how celebrating strength and resilience is the key to building better justice outcomes for Indigenous Australians. The program seeks to not only provide an understanding of the role of traditional Indigenous law, sentencing options, the importance of community, connection to country, communication, and health considerations, but also to explore the duty of the Australian judicial officer to listen and to act.
